We use your information to:

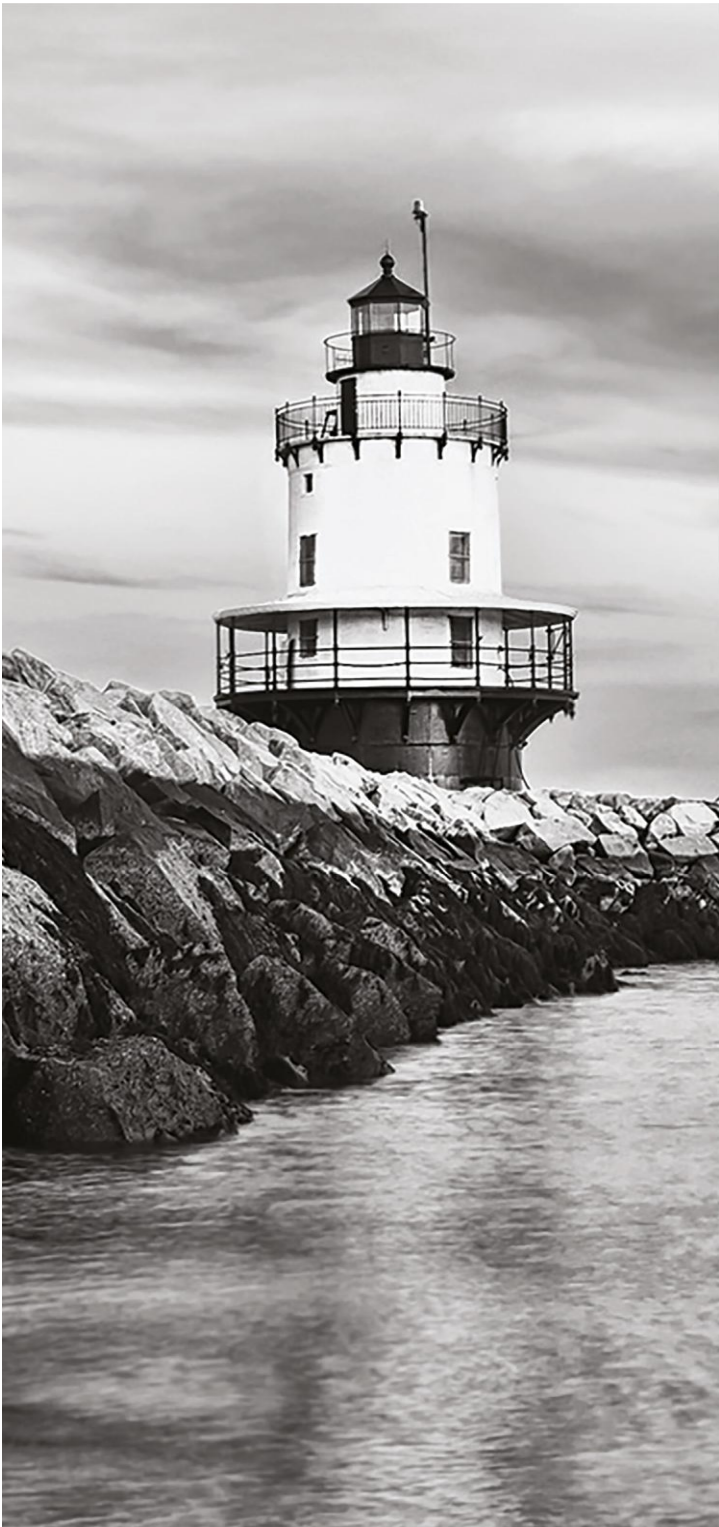
- Provide services and products related to our business.
